The Future of the Forum is held annually as an integral component of each GFMD Summit. The main objective is to take stock of the progress and achievements of the Global Forum from one Chairmanship to the next and to consider the year ahead.

2020 has presented some unique challenges to the GFMD. The Future of the Forum session at the 13th GFMD Summit offers an opportunity to reflect on how the GFMD had adapted to these challenges since the last Summit held in Quito in January 2020, and to set out resulting priorities for the year ahead.

By convention, the Future of the Forum is open to all Heads of Delegations of participating Member States and to representatives of the coordinators of the three GFMD Mechanisms for civil society, business and mayors.
